TYSON EISENHAUER, COUNTY COUNSELOR, REMINDED EVERYONE THE MEETING IS BEING STREAMED OVER ZOOM AND TO PLEASE STATE YOUR NAME WHEN SPEAKING; MARK GRABER, IT DIRECTOR, WILL WATCH FOR ANY COMMENTS OR QUESTIONS FROM THE PUBLIC.

LORI VOSS, COUNTY CLERK, PRESENTED A BILL FROM MORRIS LAING, FOR LEGAL SERVICES REGARDING FIRE DISTRICTS FOR \$2,114.00. COMMISSIONER SHRIVER MADE A MOTION TO PAY THE INVOICE FROM MORRIS LAING FOR \$2,114.00. COMMISSIONER ADAMS SECONDED. MOTION CARRIED 3-0.

LORI VOSS, COUNTY CLERK, PRESENTED A INVOICE FROM LANDMARK ARCHITECT ON BEHALF OF HARMAN HUFFMAN CONSTRUCTION, CERTIFICATE #2 FOR \$230,535.00. JIMMY WHITE, SHERIFF, ASKED FOR A FIFTEEN MINUTE EXECUTIVE SESSION AT 4:33 P.M. TO DISCUSS NON-ELECTED PERSONNEL. COMMISSIONER SHRIVER MADE A MOTION TO ADJOURN INTO EXECUTIVE SESSION AT 4:33 P.M. FOR FIFTEEN MINUTES TO DISCUSS NON-ELECTED PERSONNEL. COMMISSIONER ADAMS SECONDED. MOTION CARRIED 3-0. COMMISSIONER SHIRVER MADE A MOTION TO RETURN FROM EXECUTIVE SESSION AT 4:41 P.M. COMMISSIONER ADAMS SECONDED. MOTION CARRIED 3-0. COMMISSIONER SHRIVER MADE A MOTION TO APPROVE 3% RAISES FOR THE SHERIFF'S DEPARTMENT EMPLOYEES. COMMISSIONER ADAMS SECONDED. MOTION CARRIED 3-0. COMMISSIONER SHRIVER MADE A MOTION TO APPROVE A RAISE OF \$1.54 FOR DEPUTY CAMERON QUICK. COMMISSIONER ADAMS SECONDED. MOTION CARRIED 3-0.

TIM BRANSCOM, EMERGENCY MANAGER/ZONING DIRECTOR, REPORTED THE EOC IS BACK IN OPERATION. HE HAS RECEIVED LAPTOPS, PRINTERS, HOT SPOTS AND NEW DESKS. TYSON EISENHAUER,

COUNTY COUNSELOR, WANTED TIM TO CHECK ON THE EMERGENCY RESOLUTION THAT MIGHT EXPIRE IN JULY IF THE STATE DOES NOT EXTEND. TYSON WANTS HIM TO CHECK AND SEE IF THE COUNTY'S IS TIED TO THE STATE. TIM WILL CHECK AND REPORT BACK.

JASON WINKEL, LANDFILL/RECYCLING DIRECTOR, GAVE HIS END OF YEAR REPORT FOR THE RECYCLING CENTER AND LANDFILL. HE REPORTED RECYCLING WAS DOWN, PARTLY DUE TO BEING SHUT DOWN FOR ONE MONTH AND THEY STOPPED TAKING FROM OUT OF COUNTY RESIDENTS. SOME CHANGES HE WOULD LIKE TO SEE FOR 2021 IS TO OPEN UP THE SWAP-SHOP AGAIN, HE WOULD LIKE TO CONTINUE HAVING PEOPLE STAY IN THEIR CARS WHEN DROPPING OFF. HE WOULD LIKE TO GET ANOTHER OIL HEATER AND PAVE THE DRIVEWAY FROM THE HIGHWAY ENTRY TO BOTH DOCKS. HE WAS ASKED BY THE COMMISSIONERS TO GET PRICES ON BOTH THE HEATER AND BOTH ASPHALT AND CONCRETE PAVING AND REPORT BACK. HE REPORTED THE LANDFILL HAD MORE TONEAGE IN 2020 THAN PRIOR YEARS, PARTLY DUE TO ROOF REPLACEMENTS. HE WOULD LIKE TO UPGRADE THE SCRAPER AND THE SCALE. THE COMMISSIONERS ASKED HIM TO GET PRICES AND REPORT BACK.

SHERRY WENRICH, REGISTER OF DEEDS, ASKED FOR A FIVE MINUTE EXECUTIVE SESSION AT 5:15 P.M. TO DISCUSS NON-ELECTED PERSONNEL. DARCIE VANDERVYVER, HEALTH DIRECTOR, GAVE AN UPDATE ON COVID VACCINES. SHE IS STILL IN PHASE I. THEY GAVE 238 VACCINES AT THE POD THEY HELD AT THE COMMUNITY CENTER, THURSDAY, JANUARY 14, 2021. SHE IS PLANNING ANOTHER VACCINE CLINIC THIS WEEK. SHE REPORTED 2,077 PEOPLE HAD TAKEN THE SURVEY TO DETERMINE WHERE THEY ARE ON THE LIST TO GET THE VACCINE.
